APPLICATION FORM ACCORDING TO THE LAW ON THE PROTECTION OF PERSONAL DATA

GENERAL EXPLANATIONS

The Personal Data Protection Law No. 6698 ("KVKK") grants individuals defined as data subjects in Article 11 of the KVKK (hereinafter referred to as "Applicant") the right to make certain requests regarding the processing of their personal data.

In accordance with the first paragraph of Article 13 of the KVKK, written applications related to these rights must be submitted to our agency, which is the data controller, in writing or through other methods determined by the Personal Data Protection Board ("Board"). Within this framework, "written" applications to our agency can be made by obtaining a printout of this form and:

- Personally, or by proxy by the Applicant,
- Through a notary,
- Signed by the Applicant using a "secure electronic signature" defined in Law No. 5070 on Electronic Signature and sent to the agency's registered electronic mail address.

Below, information is provided on how written applications can be submitted to us through specific written application channels.

In accordance with the 2nd paragraph of Article 13 of the KVKK, the applications submitted to us will be responded within thirty days from the date of receipt of your request, depending on the nature of
